I run a non governmental organisation here in Harare. It is called Masikhanye food Garden The operation of the Food garden is to plant vegetables. We supply the elderly and those in need, including those living with HIV/AIDS with vegetable from the food garden and some of the produce we sell. We have been running the NGO since 2005. We are group of about 20 people.

Since its inception we have had a lot of thefts taking place from the premises of the NGO. We have reported these incidents to the police.

They promise to attend to them but they never come. Other times they come once and then they never come again. When we follow up on the cases, we are told that that particular officer has been transferred to another place, so there is nobody to carry on investigating our case(s). Already this year as the NGO we have reported 3 cases of theft. The NGO has had its equipment, the vegetables it produces, and even electricity cables stolen. I have written to the Captain of Harare Police Station stating my unhappiness with these cases that have not been attended to properly by the police. The letter was dated 25 July 2012, and till now we have received no response from The Captain or any other officer from the Harare Police Station.
