However it does not appear to have been forwarded to either General Lamoer or Commissioner Phiyega as well, and I hence now attach it hereto for their attention.

The response from the clients of WLC with respect to the proposed SAPS plan raises a number of questions pertaining to the proposal, many of which are similar to the preliminary concerns and questions which were raised by me in my letter to you last week.





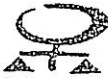
